### Transportation Breeze Card Application Form

#### ***What is a Breeze Card?***

The Breeze Card is an electronic card used to pay your fare when riding Lethbridge Transit. It looks like a credit or debit card and can be used for the full school year.

#### ***Who qualifies for a free Breeze Card?***

- a. Students that qualify for transportation i.e. live beyond 2.4 km of their boundary school and there is no school bus available.
- b. School of choice – students living beyond 2.4 km of their boundary school and school of choice are eligible for funding for a Breeze Card. For example, if a student lives within 2.4 km of Chinook High School and wishes to attend either LCI or Winston Churchill they would not qualify for a Breeze Card. If however the student lives beyond 2.4 of Chinook and wishes to attend either LCI of Winston Churchill they would qualify for a Breeze Card.

#### ***Can I purchase a Breeze Card if I am not eligible for transportation and what is the cost?***

If a student is less than 2.4 km of their boundary school or school of choice they can purchase a Breeze Card for \$46 per month. This card can only be used Monday to Friday on school days between the hours of 6:00 a.m. to 6:30 p.m.

You can purchase a non-restricted Breeze Card for \$61 per month. This card can be used anytime.

Students that are eligible for a school Breeze Card can upgrade to a non-restricted Breeze Card for an additional \$15.00.

#### ***What if I lose or damage my Breeze Card?***

If a student loses or damages their Breeze Card they will be issued a replacement card at a cost of \$5.00.

#### ***How and when will I receive my Breeze Card at the beginning of the school year?***

Students that have applied for a Breeze Card will be issued a card at the beginning of the school year. City Transit will allow students to ride for free the first few days of the new school year to allow for the cards to be distributed to students.
