203.1 Policy Development

Policy

The Board is committed to developing policies in consultation with those who will be impacted by them.

The Board authorizes the establishment of a Division Policy Advisory Committee and delegates to the Superintendent of Schools, in consultation with this committee and in accordance with the following regulations, the responsibility and authority to develop Division policies for consideration by the Board.

Regulations

- 1. Policy shall be defined as the legal and/or philosophical position with respect to an identified issue.
- 2. Regulations shall be defined as the mandatory requirements of a policy.
- 3. Procedures shall be defined as the administrative acts through which policy and regulations are implemented.
- 4. Responsibility and authority to approve Division policy and regulations shall rest entirely with the Board.
 - 4.1. Board approval of new policy shall require three readings.
 - 4.1.1. First reading shall affirm that the intent of the policy reflects the Board's beliefs and values, and provides an opportunity for the Board to discuss and amend the draft policy.
 - 4.1.2. Second reading shall provide further opportunity for the Board to discuss and amend the draft policy from first reading. Second reading shall occur at a subsequent meeting of the Board.
 - 4.1.3. Through motion, third and final reading may occur at the same meeting as second reading with the unanimous consent of the Board.
 - 4.1.4. Third and final reading establishes Board policy.
 - 4.2. Amendments to established Board policy shall be made through Board motion.

203.1 Policy Development, cont'd

- 4.2.1. Amendments of a substantive nature, which alter the original intent of the policy, shall require first, second and third readings.
- 4.2.2. Amendments which alter or add to a policy without significantly changing the intent shall be made by Board motion.
- 4.3. Unless otherwise directed by the Board, policies shall come into effect on the date it is posted to the Division's Electronic Policy Handbook or 60 days after approval, whichever comes first.
- 4.4. The Superintendent or designate shall be responsible for the maintenance and communication of Division policy and regulations.
- 5. School policies shall be consistent with Division policy and regulations.
- 6. Policies, regulations and procedures shall be subject to regular review.
- 7. The Division Policy Advisory Committee shall:
 - 7.1. be chaired by a Trustee; and
 - 7.2. have representation from the following groups: Administrators Committee, Alberta Teachers Association Local 41, Canadian Union of Public Employees Local 290, Local 2843 and the Division School Council.

The Board delegates to the Superintendent the authority to develop the procedures necessary to implement this policy.

203.1 Policy Development

For the purposes of this policy, a policy reading shall mean presentation. A verbatim reading is not required.

- 1. The Superintendent (or designate), with reference to relevant statutes, regulations and Provincial policy, develops a proposed policy statement.
 - 1.1. The proposal may be a new policy or a revision of existing policy.
- 2. In the case of a new policy, the proposed policy statement is reviewed by Executive Council.
- 3. The proposed policy statement of a new policy or policy revision of an existing policy may go to the Policy Advisory Committee (PAC) prior to the first reading, or directly to the Board for first reading as determined by the PAC chair.
- 4. Following first reading, the proposed policy statement may be forwarded to the Policy Advisory Committee for review, further review, and feedback.
 - 4.1. The Board determines which policies are to be reviewed by the Policy Advisory Committee.
- 5. The proposed policy statement is returned. Along with comments from the Policy Advisory Committee, to the Board for second reading.
 - 5.1. The Board, through motion, makes desired revisions to the policy prior to voting on second reading.
- 6. The revised policy statement is presented to the Board for third reading.
 - 6.1. The Chair of the Policy Advisory Committee moves third reading.
- 7. The approved policy shall be returned to the Superintendent for development of required procedures.
 - 7.1. Procedures are developed in consultation with division staff.
- 8. Policies and procedures shall be posted on the Division's Electronic Policy Handbook on a regular basis.
 - 8.1. In the event that a policy is not posted on the Division's Electronic Policy Handbook within 60 days, the Superintendent shall circulate the policy, in paper format, to the Division's administrators.
 - 8.2. Where a policy is to be implemented immediately, the Superintendent shall circulate the policy, in paper format, to the Division's administrators.

9. Board policies will be reviewed periodically to ensure they continue to be relevant, current and support the achievement of desired results.

9.1. Policies should be reviewed on a five-year cycle:

9.1.1. Year One: 100 Educational Philosophy

200 Board of Trustees

300 Administration

Year Two: 400 Staff Personnel

Year Three: 500 Students

Year Four: 600 Educational Program

Year Five: 700 Workplace Health & Safety

800 Business Procedures 900 Building and Sites 1000 School-Community

Formed in 1929 as an affiliate of the Canadian Home and School Federation, the Alberta School Councils' Association (ASCA) has changed over the years as parent involvement and engagement in education became increasingly valued and supported. In 1995, revisions to the Alberta School Act included mandated school councils - a forum for parents to advise the principal and school board on education matters.

ASCA's role evolved to promote and support strong school communities with effective school councils as a means to facilitate collaborations among education partners, including parents, to enhance student learning.

Today, committed to the vision of "a respected and empowered school council in every Alberta school", the Alberta School Councils' Association encourages parent engagement in education at the local (school), regional (school board) and provincial (ASCA Board of Directors) levels, primarily through the vehicle of school council.

ASCA provides resources and support to further this vision in a variety of ways, promoting positive relationships between parents, teachers, principals, central office personnel and school trustees. Supporting effective school council practices and demonstrating how parent engagement can enhance school improvement strategies, and ultimately student success, is at the core of all ASCA efforts.

ASCA advances the "parents' perspective" on education issues to government, education partner organizations and others. The collective parents' "voice" is gathered through a resolution process culminating in debate and vote at an Annual General Meeting of the Association. Resolutions carried into policy inform ASCA advocacy efforts.

A non-profit society, the ASCA is governed by an elected, volunteer board of directors comprised of parents on school councils from across Alberta. ASCA members are school councils from rural, urban, metro, public, separate, charter and francophone schools.

Wellness Committee- Edna Asem

- o Nutrition & Healthy Food Options
 - Last year, \$250,000 was received from the Alberta Government to support nutrition in the division. An additional \$50,000 will be received this year to support schools. Nutrition programs range from snack programs to daily breakfast programs depending on the school and need.

- Following the last meeting, Morag met with cafeteria providers to identify cost pressures and brainstorm around healthy cafeteria options. As a result, fruit and vegie delivery was double each month to the major high schools, to be used in foods or baking that can increase healthy options.
- Feedback from schools also included a desire to explore cultural food options in the future.
- Munchies agreed to sell no more than 355ml cans of soda and to remove the large ones.

o Digital Wellness Program

- The digital wellness team began work in late February. The team has been connecting with schools and staff around optimal and healthy technology use.
- The team has been providing micro sessions for some students. These sessions are organized to address specific incidents. For example, oneon-one conversations about screen time, digital etiquette, autonomy and personal decision-making.
- May 24th was digital wellness day. The digital wellness team provided teachers with resources to help them build digital well-being into their lesson plans.
- The teams' future plans include- parent engagement sessions, wellness information bites for parents to build digital awareness.

o Think Outside Update

 The think outside program has concluded as a success. It has inspired and equipped our teachers to get outside during a challenging time.
 Teachers are now incorporating more outdoor learning and Indigenous Ways of Knowing into their classes.

Student Forum/DIPT Update

- The Student Forum took place on February 1st to hear student voice related to wellness at school. After the forum, administrators use the data to determine 3 priorities to be included within their school Assurance Plans. Students who participated will be brought back together to discuss what has and is being done with their feedback.
- On June 14, the Diversity and Inclusion parent table event will bring together parents to reflect on the Student Forum data and receive parent feedback.

Upcoming Events & Initiatives

- Run for Reconciliation- Joel Tailfeathers shared an upcoming event for Fall 2023 which will piggyback off the Terry Fox Run and Napi's Run. The goal is to have all schools tracking mileage to run across Canada from September 18-29, 2023. More details to come.
- Joel Tailfeathers is working on a weeklong lesson plan with middle schools centring around lacrosse within physical education classes, with the incorporation of Indigenous Ways of Knowing for the 2023-24 school year.

Purpose:

To improve educational opportunities and achievement of students affected by poverty. To determine the Division's progress in addressing poverty and make recommendations to the Board where deemed appropriate.

To heighten staff awareness and promote action on issues related to poverty. Meeting dates are October 17, December 12, March 12, and May 14. Meeting time is 1:00 to 3:00 pm.

The committee shall consist of two Trustees, one of whom shall act as chair of the Poverty Intervention Committee, Making Connections Program Coordinator who shall act as co-vice chair, Counselling Coordinator who shall act as co-vice chair, Indigenous Education Coordinator, two Division School Council representatives, a principal and a vice-principal (one from secondary and one from elementary), three teachers (elementary, middle and high school), counselling representative, CUPE 2843 representative, CUPE 290 representative, community member, and a representative from Alberta Health Services.

Division Wellness Committee:

General purpose is to promote and facilitate healthy lifestyles among students, families, and staff of the Division. Meeting dates/times are October 2 (already passed), Jan 15 and June 3. All meetings will be 1:15pm-3:15pm at the Education Centre.

DIVISION SCHOOL COUNCIL GUIDELINES

Draft - Updated November 2023 (underlined and italicized is new language, strike through is old language removed)

RATIONALE

The school council and school-based decision-making impact education at the site. However, issues that arise at school council meetings may be regional, provincial or affected by Division decision. According to the Education Act, "a school council may advise the school board respecting any matter relating to the school". While a trustee might attend a school council meeting and the principal can bring Division news to the school, school councils can seem isolated. Forming a Division school council with representatives from each of the school councils, the school board and the Superintendent of Lethbridge School Division will improve communication and promote cooperative action among our school councils.

FUNCTIONS OF THE DIVISION SCHOOL COUNCIL

- a) Share information among school councils
- b) Consult with other school councils on wider education issues
- c) Communicate information both ways between the Division/school board and the school councils
- d) Provide input to the school board and central office on broader education issues, including the Division budget
- e) Inform the community about education concerns
- f) Promote school council in-service and training
- g) Assist in providing parent representatives for standing and ad hoc school board committees

STRUCTURE OF DIVISION SCHOOL COUNCIL

Membership shall include:

- 2 <u>A minimum of 1</u> representatives from each school council; however, if more than one representative from a school council is present, it is understood that each school has one vote should any decision be decided by Division School Council
- 1 ATA Representative (if available)
- 1 Principal Administrator Committee Representative
- the Superintendent (who is a non-voting member); and
- 1 Board of Trustee Representative (who is non-voting member), <u>one alternate trustee. Meetings</u> are open to all Trustees to attend.

Because the Division School Council is not intended to detract from the legislated powers of the School Council, any formal actions of the Division School Council require consensus of all School Councils attending the meeting.

A Division School Council executive consisting of a chairperson, vice-chair, and secretary will be elected annually.

There will be a minimum of 5 meetings, normally occurring on the first Monday evening of the month held at the board office. These meetings are open to the public.

Agenda items should be forwarded to either the chairperson or the superintendent's executive assistant. The agenda will be drawn up jointly by the chairperson and the Superintendent.

CALL TO ORDER will be the reference for rules of procedure during the meetings.

Board Support for Division School Council Schools

- 1. The Division funds the registration fees of all School Councils for Alberta School Council Association (ASCA) membership.
- 2. Division provides each school with \$250 for parent professional learning can be used to offset costs to attend the annual ASCA conference.
- 3. Division pays for ASCA conference registration (1 per school).

Division School Council November 6, 2023

Below is a summary of factors we must consider when creating the school calendar. This list isn't comprehensive but gives us a good summary of key considerations. Obviously, some of the most critical considerations are the impact the calendar has on students, staff and our school communities.

2023-24 Calendar

- 196 teacher days total
- 179.5 student days for elementary
- 180 student days for middle school
- 181 student days for high school

Education Act

- The Education Act (205) states that teachers cannot be required to instruct students for more than 200 teaching days in a school year.
- 2 days are set aside for Teacher's Convention per the Education Act

Division Policy

Policy 601.2.1 School Year provides guidelines for creating the yearly calendar. Below are some
of the key elements of the policy.

Each school year shall normally:

- 2.1. provide for five days for teachers prior to the date students begin attending;
- 2.2. have students begin classes on the day following Labour Day;
- 2.3. provide for a two week Christmas break that begins after the last Friday prior to Christmas Eve;
- 2.4. provide for a Family Day break on the Tuesday and Wednesday following Family Day;
- 2.5. provide for a ten day Easter break beginning on Good Friday;
- 2.6. provide for an afternoon and a morning for parent teacher interviews in the fall, and a morning for parent teacher interviews in the spring.
- 3. Breaks from instruction and days assigned for professional learning, preparation, or parent-teacher interviews will be common for all schools, when possible.

Instructional Hours

Alberta Schools are required to have the following instructional hours for students:

- 1000 hours of instruction for grade10-12 students
- 950 hours of instruction for grade 1-9 students
- 475 hours of instruction for Kindergarten students

Assignable time for teachers

According to the Provincially negotiated Collective Agreement, teachers can be assigned a
maximum of 1200 hours in a single school year. This includes instruction, supervision and other
assigned duties.

Coordination with Holy Spirit

• Lethbridge School Division and Holy Spirit School Division share busing, as such both Divisions must coordinate their calendars.

Bussing and Bell Times

Many of our buses do "double runs" which means they pick up students and drop them off at
one school and then go and pick up a different group of students and then drop them at another
school. This means that schools have different start times, which means they may need
adjustments to their calendars to make sure they have the correct instructional hours.

Diploma Exams and PAT's

• Diploma exam and PAT dates are set by the Provincial government. These dates impact when our school year ends and when our semester break happens.

High School, Middle School, Elementary

- Each grade level has different requirements, for example, high schools will typically have a semester break in January. This break is not required at the elementary level as they are not on a true semester system.
- We have to create a calendar that has similar number of days in semester 1 and 2 for high schools.

Timing of Holidays

• The timing of holidays has a significant impact on the calendar. For example, when Labour Day, Christmas and Easter fall on the calendar impacts how the school year is organized.

Stakeholder Considerations

• It is always important to consider the impact our calendar will have on our stakeholders. We have to consider, what is best for students, staff and the families we serve.
