- 7. Business Arising from the Minutes
 - a. Screen Time Use & Content questions to bring back to your school council regarding TIME and CONTENT.
 - i. Danica MMHE some parents had concerns because during MINDFUL EATING students are not allowed to talk or move around the room. Admin inquired to determine who is doing this and found that fewer teachers than actually thought were doing this. Mindful eating varies based on grade level. Some teachers are watching you tube and movies. School council spoke about content shown and concerns. Students are feeling like they are in trouble when not allowed to speak or move around. Talked about the information coming home and what could change moving forward

- FAVORITE audio book listened to 2 lunchbreaks a week
- ii. Tisha GS Lakie/ Nicholas Sheran still concerned with content shown and amount of time using these videos in class! Would like to see more basic content shown.
 - In contrast: Was amazed how kinder kids were captivated by a storyteller who had NO visuals and kids were incredibly engaged. Shows that videos are not a necessity.
- iii. Mike Nightingale questions/assumptions/thoughts on next steps - Thinking about when screen time is being used (announcements on TEAMS, videos on at lunch, DPA and there is something on the screen). Reality is the accumulation of this screen time... Is admin aware of this and to what extent is this on their radar? Will have a discussion with admin team.
- iv. Tasha Senator Buchannan screen time is used as a classroom management tool so that classroom teachers can take a break and then an EA supervises up to 4 classrooms.
- v. Andy Tyslau (Principal) observed at Plaxton Elementary school as a livestream of chicks hatching in Learning Commons (no audio), hamster going through a maze on You Tube, books being read, old curious George videos... trying to balance supervision and teachers getting a break.
- vi. Parent comment: When a teacher sends out a request to watch a movie that is not PG, I feel respected as a parent that I have been notified and this strengthens the relationship between school and home.
 - Andy Tyslau at Dr Plaxton "G" is allowed. Anything beyond G must have a letter that goes home that outlines the curricula outcomes and also WHY it is rated as higher than G. IMDB is a great data base to show what content is in. Common Sense Media also is a great site to use.

- 8. Trustee Report March 25, 2025, Board <u>Highlights</u> (Genny)
 - Capital plan was passed! (executive summary LOTS of information)
 - New school approved for the west side (elementary), planning money for LCI modernization, continuing to advocate for other schools as well
 - o QUESTION: Are any of these plans a direct result from the accelerated budget?
 - ANSWER: YES! Absolutely and from the advocacy from the Board and the division and the cooperation from the City.
 - 2nd guarter financial reporting available
 - Transportation: Government changes to transportations distances was to be implemented in September, but this has been reverted back to the current (old) funding model.
 - Meg Fester Presentation: Advocate for food security for students and families

- School Fee schedules need approval from the Board areas of concern, inconsistency between schools, areas needing more information, conversation is tabled until more info is available
 - School based fees include: options, athletics, extracurricular, international trips, anything on SchoolCashOnline.
 - Policy in place for any items increasing by more than 5%
 - Parent QUESTION: asking about discrepancy seen between schools (particularly high schools)
 - ANSWER: recognition of this and intension to create equity
 - QUESTION: Why are extravagant experiences needing to be the hook? Can we brainstorm ways to make options more affordable and perhaps stay within our backyard without the high price tag?
 - ANSWER: we will continue to represent this concern and discuss this as a Board as we seek to do what is best for students and families.
- School council conference support changed from mileage to fuel to leave more money for hotels and deadline was adjusted to make it flexible based on ASCA resolutions available.
- Code of Conduct 2nd reading. Tabled due to significant changes made and people wanting more time to read and reflect on it.
 - O QUESTION: Will the proposed draft be in the Board package?
 - o Answer: yes, there will be a draft that represents all the work will be available.

11. Admin Committee Report - Andy Tyslau

- Indigenous Learning Team (Joel Tailfeathers and Melanie Morrow and school reps) trip to Head Smashed IN Buffalo Jump. Was great Professional Learning (PL)for teachers who can then share with their schools
- Admin Professional Learning (PL): Assessment and Outcome Based Reporting Calgary Board of Education (CBE) coming to share their journey towards Outcome Based Learning in order to advance thinking at a secondary level.
- Early phases of planning for next year... Starting with transitions from grade 5-6s and grade 8s-9s. Gilbert Paterson Band came to Plaxton to showcase the Band program at middle school. Watch for registration and option changes etc.

12. Superintendent's Report

- a. Technology Evergreening what happens to school council purchased technology?
 - i. Generally goes to recycling company in Calgary (MAY get repurposed to different levels) (\$0.75 / lb) (Mike)
 - ii. Admin could have a conversation with school council as to what wanting to do with them. (Mike)
 - iii. If laptops have been donated, they are property of the school but if they are retained as part of school council, then this process would be dictated by the school council by-laws or operating procedures (group discussion)
 - iv. Division must be working with each school council this does come with a cost to the division (upkeep and removing software etc) (Mike)
 - v. Parent comment— wanting to provide technology access for families from their own school community that may not have access at home.
 - vi. Parent If a school council wants to buy tech, does this have to be through the division?

Answer: This is a cooperative/collaboration in order to ensure the software/hardware is compatible. (Mike)

QUESTION: How do we retain possession of this tech as a school council?

ANSWER: Society CAN own property/assets, but school councils typically purchase items for donation and so fundraising for assets then are donated to the school and everything done should be through motion and resolution. Do you have historical evidence to show that these devices are NOT donated? (group)

Reminder that all Division technology needs to be compatible with the Division and connected to the network. (Mike)

QUESTION: Could the division look at tech that is ready to be evergreened and instead of recycling, could families be offered these devices?

SBE (Michelle) – Question - the devices that are purchased by the school council, can these devices, once needing to be evergreened, instead of being recycled, offered to families without access to any tech?

SBE (Tasha) – concern, the money paying for the tech is from the specific school council while the evergreening recycling funds are going to the division pool instead of giving it back to the school community.

Shelley – typically your school council/society has a purpose to raise money to benefit for the school and then this is gifted and released to the school to be used as they need. Now, they are no longer school council devices.

Encourage your school council to advocate with the trustee liaison

Genny – school councils are transient and don't have consistent school council members so this becomes a difficult process.

Mike – Summary - there is a possibility to have the devices back. BUT: If you are ever considering this as a school council, you need to work with admin as there are costs to the division (adding/removing operating systems and staff time needed).

- c. ICE Scholarship
 - Wonderful night showcasing the amazing kids in our division!
- d. Staffing and Budget
 - Beginning for 2025/2026 school year. New school opening so staffing has begun!
 - Budget is not what the division hoped for No increases in these three major areas...
 - Base Grant zero increase in this funding and yet COSTS ARE RISING...
 - Announcing money for next year or three years?
 - How quick do we get our funding profiles?
 - There were SOME increases but these are minimal in comparison
- e. Collective Bargaining Processes out of respect for negotiation, this is only a high-level view.
 - i. Teachers (2 tiered bargaining process: (1) Central Table ATA with the government. Public knowledge is that there is an agreement that will be voted on in May. (2) Local Bargaining only certain items that can be discussed)
 - ii. CUPE 290/CUPE 2843 (only local bargaining) doing some negotiations here in Lethbridge (all strikes throughout the province have been dissolved)
